

BCA Smartcash Credit Card

The **BCA Smartcash Credit Card** is a card payment method issued by BCA for business transactions. BCA settles the payment obligation in advance, and the cardholder must pay at the designated time, either in full or in installments.

A Key Features

- Can make transactions at merchants and BCA ATMs.
- Cash withdrawal transactions can use up to 100% of the card limit.
- BCA Installment is available.
- Credit limit for the BCA Smartcash Credit Card is IDR10,000,000 to IDR100,000,000 for general customers and IDR50,000,000 to IDR250,000,000 for merchant customers.

Remark: The credit limit will be determined based on BCA's analysis.

- The autodebit account selected by the customer at the time of applying for the BCA Smartcash Credit Card will automatically be used to pay bills arising from transactions made using the BCA Smartcash Credit Card.
- BCA credit card activation can be done by sending an SMS to 89888, Halo BCA, myBCA, and BCA mobile.
- The minimum payment is 5% of the total bill.
- The validity period of the BCA Credit Card is as stated on the card.
- Contact transactions can be carried out using the dip/swipe method on EDC machines and by using a PIN/signature* as authentication. Activation of the PIN can be done through the myBCA app, BCA mobile, ATMs, or the official BCA website.
- The billing statement and credit limit for the BCA Smartcash Credit Card are separate from those of other BCA credit cards.
- Customers can request closure of their BCA Credit Card at branches or via Halo BCA. All transaction charges for BCA Credit Card transactions must be paid in advance by the cardholder.
- BCA shall inform all changes to the benefits, fees, risks, terms and conditions of this Product and/or Service through any means in accordance with applicable legal provisions.
